

COOKIE POLICY

By browsing or using our website, you agree to this Cookie Policy (hereinafter referred to as the “Policy”). If you do not agree with the Policy, please do not use the website. By continuing to use our website, you accept the cookie terms outlined in this Policy.

1. Explanation of Cookies

Cookies are small text files stored on your device (such as a computer, smartphone, or tablet) when you visit our website. On your next visit, our website can recognize your browser using these cookies.. They help us identify which sections of the website are effective and which need improvement.

Besides, we allow third parties to use cookies on our website. This means that our website permits third-party companies to place their own cookies on the device you use to access our website.

We use cookies for the following purposes:

- To ensure the website operates and functions correctly
- To enhance the website by identifying your preferences, providing relevant information
- For marketing purposes

Cookies allow the website to remember your preferences, such as language, font size, and other personalized settings, so you don't need to adjust them each visit. They enhance performance and improve the user experience.

Cookies are typically stored in your device's browser automatically. However, you can manage or delete cookies yourself. The section below, titled “How to Manage and Delete Cookies”, outlines the methods available for controlling cookies. Disabling cookies and similar technologies may affect website functionality. If you refuse cookie processing, our website will only use strictly necessary cookies. Note that disabling or blocking cookies might limit your ability to fully use the website.

2. Cookies and Its Types

We use two types of cookies: session and persistent cookies.

- **Session Cookies** are temporary files created by the website to store information about your current session. They remain active while your browser is open and are deleted when you close it. These cookies help retain your choices from the previous page, so you don't have to re-enter the same information.

- **Persistent Cookies** are stored on your device for a specified period, even after closing your browser. Created when you visit our website, they remain on your device until you delete them or they expire. Persistent cookies allow us to identify you as a unique user on return visits and help recall your previous actions.

Our website uses cookies created by us and third-party companies to analyze visitor activity and improve the website performance. The collected information may enhance the website's operation and its sections.

We provide the expiration time for each cookie based on available information. Please note that the expiration dates of third-party cookies are determined by the companies that collect these cookies and may be changed by them at any time.

Below is a list of the different types of cookies we use on our website.

Strictly Necessary Cookies

These cookies are essential for the website to function properly and cannot be disabled in our systems. The number of strictly necessary cookies used is minimal. They are required to ensure the smooth and uninterrupted operation of the website. Typically, these cookies are set only in response to actions you take that amount to a service request, such as adjusting privacy settings, logging in, or completing forms. While you can configure your browser to block or alert you about these cookies, doing so may cause some parts of the website to stop working correctly. These cookies do not store any personal information. Strictly necessary cookies are not used for marketing purposes or to track your behavior beyond the core functionality of the website. Their primary purpose is to enable you to use the website as intended. Because strictly necessary cookies are critical to the operation of the website, they cannot be disabled unless you choose to stop using the website altogether.

Performance Cookies

These cookies collect information about how you interact with the website and how our website performs. They help us identify areas that need improvement, track the number of visits and traffic sources, and measure and enhance the overall performance of the website. Performance cookies enable us to see which pages are most and least popular and understand how visitors navigate through the site. All data collected by these cookies is anonymous.

If you choose not to allow these cookies, we won't be able to track your visits or monitor the website's performance. You can disable performance cookies at any time using the cookie consent banner.

Functional Cookies

These cookies allow the website to remember your preferences and provide enhanced, more personalized features. They may be set by us or by third-party services that we have integrated into the website. If you choose to disable these cookies, some or all of these services may not

function correctly. You can manage your preferences and disable functional cookies at any time using the cookie consent banner.

Targeting and Analytics Cookies

These cookies are used to track your activities on and off the website, collecting information about how you interact with the site. This data helps us understand how you use the website and identify areas for improvement, enabling us to deliver more relevant and personalized advertising that is better suited to your interests.

These cookies also help third parties understand your preferences so they can show you ads that are more interesting and useful. Targeting and analytics cookies may be set by us or by third parties through our website. They may be used to create a profile of your interests and display tailored advertisements on our site or across other websites. These cookies work by uniquely identifying your browser and device. You can choose to disable targeting and analytics cookies at any time via the cookie consent banner.

To collect analytics data, we use the Yandex.Metrica platform. LLC “Yandex” processes this information to assess your use of the website, generate reports on site activity for us, and provide other related services. Yandex handles this data in accordance with the terms outlined in the Yandex.Metrica service agreement.

You can refuse the use of cookies by adjusting your browser settings. You can also use the tool available at <https://yandex.ru/support/metrika/general/opt-out.html>. However, this may affect the functionality of certain features on the website. By continuing to use this site, you consent to Yandex processing your data as described above and for the specified purposes.
